SESSION 2015-16

Dated 06/08/2015

Today, on 06/08/2015, the first quarterly meeting of IQAC for the academic - session 2015-16 was held under the chairmanship of the Principal of the college. Following members were present in the meeting-

At the beginning of the meeting Dr J N Pant, co-ordinator IQAC, briefed the members of the achievement of the last session.

- It was informed that admissions in the last session were according to the merit and within the available seats.
- Intercollegiate tournament of University level in Hand Ball was organized by the college.
- In athletics, college team secured third place at University level with two gold, one silver and one bronze medal. It was a big achievement for this college of remote area.
- Research papers were also published in international journals by Dr P. C . Mathpal and Dr Poonam Miyan.
- Biometric attendance for teachers and staff was implemented.
- Faculty members prepared their teaching plans and completed syllabus in time.
- Assignments were given to P G students and these were evaluated by the teachers.
- College teams in cricket, volley ball, table tennis, badminton and athletics were sent to participate at University level intercollegiate tournaments.
- NSS unit was used in programmes related to generation of environmental awareness

Although, members expressed satisfaction but at same time called for more activities in the college.

Minutes—it was resolved that-

1. Admission shall be given on the basis of merit and within the limit of available seats.
2. Efforts shall be made to establish a study centre of UOU in the college and an MOU to this effect shall be signed
3. A computer certificate course shall be started in the college under UTAKRSH programme. Upliftment of the computer lab shall be done for this purpose.
4. Faculty shall be asked to go for orientation /refresher course and also publish research papers.
5. Assignments shall be given to students and these shall be properly evaluated.
6. Important of teaching plans was emphasized and teachers shall be asked to prepare these and complete their courses in time
7. co-curricular /extracurricular activities should be pursued.
8. To encourage sports activities college teams should be sent to participate in inter collegiate tournaments organized by the University.
9. NSS unit should be used to promote gender equality and social and environmental awareness programmes.
10. Maintenance and repair works should be under taken
